


## Taranaki Business Survey

- Monitors economic confidence by Taranaki businesses and their views on key business issues.
- Undertaken by Venture Taranaki 6-monthly since 1999.
- Survey sent to 1500 Taranaki businesses.
- Cross section of industry type, location and size.
- Spans a number of **standard economic questions**.
- Plus special topics:
  - 2018 highlights; challenge
  - Change and transition
  - Future regional economy and lifestyle



#### NZ Economic Conditions: next 12 months



Downturn ebbs from peak?

#### But confidence remains weak

- Same: 53% up from 47%
- Improve: 18% down from 20%
- Deteriorate: 24% was 31%
- Don't know: 5%


#### **Industry conditions: next 12 months**



Downturn ebbs. Confidence ebbs. The status quo of change now the new normal?

- Remain same: 52% up from 47%
- Improve: 24% down from 29%
- Deteriorate: 22% was 23%
- Don't know: 3%


#### Sales: next 6 months



Sales following similar pattern of market readjustment?

- Improve: 36% down from 45%
- Remain same: 54%
  43% previously
- Deteriorate: 12% down from 18%
- Don't know: 3%

#### Taranaki business: concerns







## Other Factors Impacting on Business

- **"Govt policies** impacting O&G, reducing high earners & spending"
- "General market uncertainty is destroying confidence, delaying decisions"
- **"Declining confidence** in dairy. Finance getting tighter"
- "All costs going up, including price of water"
- **"The increase in the minimum wage** gap between that and our lower paid jobs is smaller, harder to attract staff"
- "Demographics of clients too many retirees still in business"
- **"Transport** domestic flight options decreasing, and bus links to Auckland/Wellington are limited difficult to expand tourism"
- "Increasing Govt regulation"

#### **Employee numbers – next 6 months**




Employment holding firm – with possibilities of some short term growth?

## 2018 – Economic Challenges


- Govt stopping issuing new oil and gas permits
  - "Oil/gas impacts across the board re: spending"
  - "O&G ban without a viable alternative"
  - "Diversifying away from the oil industry"
- "Adjusting to the new coalition policies"
- "Govt commitment to the regions mixed messages"
- Agriculture
  - "Fonterra/Dairy payout/being down reduced confidence"
  - "Stopping the environmental impact of farming on our rivers"
  - "Risk of M. bovis hitting our farmers"
  - Weather-related challenges to agricultural sector
- Yarrows stadium
- Employment, ageing workforce
- "Hawera/Taranaki voted an unattractive place to live"
- Roading impact on transportation of goods

## 2018 – Economic Highlights

- Infrastructure:
  - Mount Messenger/SH3 improvements announced
  - Major roading funding
- **Primary sector** dairy production is up 5-10%
- Taranaki lifestyle and attractions
  - People relocating to Taranaki
  - Attracting tourists
  - Events such as garden festival
- Investments/projects
  - Methanex turnaround investments
  - 8 Rivers potential
  - Airport extension/expansion
- New and emerging businesses developing


### Is the region at a pivotal time of change?

How strongly do you believe that the region is at a pivotal time of change?




# Industries facing biggest change in next 10 years

Industries facing the greatest challenges over the next 10 years




## Taranaki business environment in 10 years

Taranaki business environment - in 10 years time




## Taranaki's lifestyle destination in 10 years

## Other changes that may happen...


- "Taranaki will either not have a tertiary education provider or we will have a significantly improved and more relevant one"
- Population
  - Increased population
  - Static population growth relative to rest of NZ
  - May revert to rural obscurity
- Shift in finance and transport to rely heavily on blockchain technology for payment solution, product tracking and product authentication.
- Infrastructure: Roading, runway extension
- **Technology:** "People will need more support to navigate the proliferation of online services"
- Energy
  - Greater focus on renewable energy production
  - Shortages of gas for industry

## Other changes that may happen...

- "Social expectations of sustainability will grow markedly"
- Climate:
  - "Dramatic weather events
  - With sea level rising, most of Taranaki's beaches will disappear
  - More cropping on land
  - Climate change will have a significant impact on all sectors through extreme weather events, coastal erosion, agricultural practices, dislocation of populations and security"
- "Greater appreciation for cultural aspects of Taranaki to attract and enrich visitor and resident experience".
- Work and business
  - Move to 4-day work week
  - High unemployment
  - More business diversity
- More pressure on welfare state e.g. geing/superannuation





TARANAKI - NET MIGRATION 2001 - 2018: YEAR TO JUNE


